

PEWARISAN ASNB 2026 ("Campaign")

A) Terms and Conditions

1. This Campaign is organised by Amanah Saham Nasional Berhad (Registration No. 197901003200 (47457-V)) ("ASNB").
2. This Campaign shall commence from 00.00 hours (GMT +8) on 1st July 2026 until 23:59 hours (GMT + 8) 31st December 2026 ("Campaign Period"). ASNB reserves the right at its absolute discretion, to vary, postpone, re-schedule and/or extend the Campaign Period at any time.
3. This Campaign is open to all new and existing ASNB unit holders aged eighteen (18) years old and above who are eligible to subscribe to the Hibah Amanah or Pengisytiharan Amanah services (also known as Pewarisan ASNB) ("Pewarisan ASNB"), including all employees, staff and immediate family members (spouses and children) of the employees and staff of Permodalan Nasional Berhad (Registration No. 197801001190 (38218-X)) ("PNB") and its group of companies ("PNB Group") and/or the following entities whichever is applicable ("Participant"):
 - i. PNB;
 - ii. ASNB;
 - iii. ASNB Wakalah Sdn Bhd (Registration No. 202101002976 (1403274-P));
 - iv. Pelaburan Hartanah Nasional Berhad (Registration No. 198801008611 (175967-W));

 - viii. Any other company and/or entity as may be determined by ASNB.
4. To be eligible for the Campaign, the Participant must fulfill the following requirements:
 - i. be a unit holder of at least one (1) of ASNB unit trust funds;
 - ii. maintain a minimum balance of one thousand (1,000) units in the unit trust fund account (excluding units which are under financing/collateral/Employees' Provident Fund (EPF) Members' Investment Scheme) to be eligible for registration for Pewarisan ASNB;
 - iii. subscribe to Wakaf ASNB with a minimum contribution amount of Ringgit Malaysia One Thousand (RM1,000.00) only during the Campaign Period;
 - iv. not a subscriber of Pewarisan ASNB; and
 - v. submit the required Completed Documents (as defined below) for Pewarisan ASNB (refer to "Campaign Offer and Mechanics" terms below) at any ASNB branches during the Campaign Period. For the online pre-registration process, the Participant must submit the required Completed Documents at any ASNB branch within ninety (90) days of completing the pre-registration form, and such submission must occur during the Campaign Period.

B) Campaign Offer and Mechanics

1. Eligible Participant who subscribes to Wakaf ASNB with a minimum contribution amount of Ringgit Malaysia One Thousand (RM1,000.00) during the Campaign Period will be entitled to the discounted registration fees for Pewarisan ASNB worth Ringgit Malaysia One Hundred (RM100.00) only for first time registration.
2. Registration Process
 - 2.1. First step, Participants must subscribe to Wakaf ASNB with a minimum contribution amount of Ringgit Malaysia One Thousand (RM1,000.00) only during the Campaign Period via the following platform:-
 - i. Over-the-counter at ASNB's;

- ii. myASNB, which refers to the portal (www.myasnb.com.my) and/or the mobile application; or
- iii. Over-the-counter ASNB agent (e.g. Bank Muamalat Malaysia Berhad and other authorised agents offering Wakaf ASNB services).

2.2. Next step, Participant may register for Pewarisan ASNB either through online pre-registration or by direct application at ASNB branch. The registration process must be completed within the Campaign Period.

2.3. The registration process for Pewarisan ASNB for each method is set out in the table below.

Step 3	Submit the Completed Documents as stated in Step 2 and complete the registration at the nearest ASNB branch within ninety (90) days from the date of submission of the online pre-registration and such submission must occur during the Campaign Period. If the Participant does not submit the Completed Documents at any ASNB branch within ninety (90) days after completing the online pre-registration, and if the Participant wishes to continue with registration, the Participant must re-register; either by completing a new online pre-registration or by applying directly at any ASNB branch.	Submit the Completed Documents as stated in Step 2 to complete the application process.

C) Other Terms and Conditions
